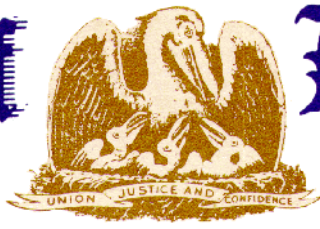

### PROCLAMATION NO. 9 BJ 2010

---

**AMEND EXECUTIVE PROCLAMATION NO. 73 BJ 2009  
SPECIAL ELECTION - JUSTICE OF THE PEACE - TANGIPAHOA PARISH**

---

**WHEREAS,** R.S. 18:621(A)(2) and (3) mandate that the governor shall call a special election to fill a vacancy in an existing judgeship when more than twelve (12) months of the term remain unexpired, in accordance with the provisions of R.S. 18:621(A)(3) and/or the dates for elections set forth in R.S. 18:402;

**WHEREAS,** Executive Proclamation No. 73 BJ 2009 was issued on November 17, 2009, calling a Special Election for the office of Justice of the Peace, Ward 8, Parish of Tangipahoa due to the resignation of the Honorable E. Keith Bardwell, effective November 3, 2009; and

**WHEREAS,** it is necessary to amend Executive Proclamation No. 73 BJ 2009 to change the dates of the Special Election and qualifying period;

**NOW THEREFORE I, Bobby Jindal,** Governor of the State of Louisiana, by virtue of the authority vested by the Constitution and laws of the State of Louisiana, do hereby order and direct as follows:

**SECTION 1:** Section 2 of Executive Proclamation 73 BJ 2009, issued on November 17, 2009 is amended as follows:

Any qualified person desiring to become a candidate for said office shall file a notice of candidacy, accompanied either by a qualifying fee or a nominating petition, as required or authorized by law, with the appropriate election official in the manner and form, and under the procedures and conditions, provided by R.S. 18:461, *et seq.*, and all other applicable provisions of the Louisiana Election Code, R.S. 18:1, *et seq.*, during the period commencing on Wednesday, July 7, 2010 and ending at 5:00 p.m. on Friday, July 9, 2010.

**SECTION 2:** Section 4 of Executive Proclamation 73 BJ 2009, issued on November 17, 2009 is amended as follows:

The primary election shall be held on Saturday, October 2, 2010, and the general election shall be held on Tuesday, November 2, 2010, at the times and places, and in the manner, prescribed by law.

**SECTION 3:** All other sections, subsections, and paragraphs of Executive Proclamation 73 BJ 2009, issued on November 17, 2009 shall remain in full force and effect.
