**Guidelines: Students attending Louisiana universities who are working toward a Masters Degree, Ph.D., or conducting post Ph.D. research with a focus on environmental issues are eligible to apply.** Current members of the EE Commission may not apply. Research grants will be awarded to applicants in single amounts not to exceed \$1,000.00.

**Research proposals that are funded must be based on sound scientific principles and have an environmental focus. All monies must be spent to support the research.** (The EE Commission will not provide indirect costs to universities or tuition fees.) Applicants, by law, will receive Tax form 1099 declaring receipt of these funds, unless the application is made through an agency, university or foundation. Funds may be used to purchase materials and/or equipment necessary to conduct the research, and provide travel and lodging to and from field sites during data collection. All research conducted must follow the university IRB guidelines to ensure compliance. A letter of support from the student's major advisor must be included in the proposal. Documentation of the research project and accompanying receipts for purchase of materials or equipment are required for the mid-year and final reports.

**All research proposals must be completed and a summary report submitted by June 20, 2008.** Failure to comply with these guidelines will disqualify the applicant for any future grants from this agency. Final reporting information will be included in the packet to awardees. Note: The Office of Environmental Education reserves the right to advertise the funded projects for public information services that may include the Office of EE website, printed materials and other means that may be used to inform or to assist educators. All awarded applicants are encouraged to attend the **2008 Environmental Education Symposium** to showcase their research and network with environmental educators and resource providers.
